

# Wealth Structure Review Service

With this as a starting point, we work with our clients to develop the strategies that will safeguard the family and best protect their assets in a dynamically changing world environment.

By gaining a deep understanding of the values, dynamics and shared objectives of the families that we advise, we bring a long-term, flexible vision to strategic wealth planning. This is achieved through collaborative discussions with families around estate and succession planning, equitable inter-generational wealth transfer and family business custodianship, leadership succession and governance. We work with families to build a platform for the future management of their wealth, which may include helping them to:

- Compose a family charter
- Establish family governance structures (family councils, boards etc.)
- Provide next generation mentoring and education
- Address and deal with family and business disputes
- Appraise existing family and business governance arrangements.

## Family Wealth

We understand that Ultra High Net Worth families often have large and complex private wealth structures which have developed over a period of time in order to address issues such as the following:

- Commercial pursuits
- Asset protection
- Intergenerational wealth transfer
- Legal and tax

MDR Mayfair works with families to offer a four stage Wealth Structure Review Service, often in conjunction and in collaboration with their existing professional advisers.

#### Stage I - Review

- Review the family's current succession plans and provisions.
- Review the family's private wealth structure which is likely to consist of companies (holding / operating / dormant), trusts, partnerships etc.
- Identify external risk factors (for example - asset protection, legal and tax).

### Stage 2 - Report

- Prepare a family balance sheet, income account and cash flow statement (where necessary).
- Prepare a written report which will include the following:
- An appraisal of the family's current succession plans and provisions
- A summary of the financial position of each entity within the family's current wealth structure
- A detailed analysis of the corporate governance arrangements that are in place within the family's current wealth structure.



### Stage 3 - Planning

- Formulate the family's strategic wealth planning blueprint into a written proposal.
- If required, organise estate, legal and tax planning advice from relevant jurisdictions.
- Identify the nature, form and location of the family's future private wealth structure.
- Compose a plan and timetable to effect the transfer of the family's assets to the new private wealth structure (if required).

## Stage 4 - Implementation

- Organise the incorporation /
  establishment of any new wealth vehicles
  (such as trusts, companies, partnerships)
  as required under the family's new wealth
  planning blueprint.
- Organise the appointment of professional service providers such as trustees, protectors, directors, and officers to family wealth structures.
- Coordinate the effective and timely transfer of assets from the family's existing wealth structure to the new structure.
